

Feher Rate Sheet

Effective Date: February 1, 2025

1. Mediations

- **Half-Day Mediation:** \$3,000 per 1/2 day + \$1,000 nonrefundable administrative fee
- **Full-Day Mediation:** \$5,000 per day + \$1,000 non-refundable administrative fee
 - Includes all preparation, pre-mediation conferences, and a four-hour or eight-hour same-day mediation session.
 - Mediations exceeding the stated maximum hours are billed at \$500 per hour.
 - Note: Additional hours for half-day mediations may not be available depending on the mediators schedule.
 - **Advance Payment:** Professional and administrative fees are invoiced upon scheduling.

Cancellation Policy: Notice of cancellation or rescheduling of a mediation must be submitted in writing by each side at least 14 days prior to the first mediation hearing date. Late notice will require the requesting party to incur 100% of the fees associated with that hearing. The administrative fees are non-refundable.

2. Arbitrations

a. Simple Arbitrations (e.g., UIM Cases)

- **Plenary Session:** \$7,500 per plenary eight-hour same-day session hearing + \$1,500 nonrefundable administrative fee
 - Case management conferences, status conferences, motion practice and preparation of reasoned award at \$500 per hour.
 - **Maximum Hours for Award Preparation:** Typically, not exceeding 10 hours (determined at pre-arbitration conference).
 - **Advance Payment:** Administrative fees and 10-hour retainer for professional fees will be invoiced at setup.
 - **Payment for Scheduled Sessions:** Required 90 days prior to the start of plenary sessions.
 - Hourly fees are billed as incurred, we reserve the right to invoice for additional retainer upon use of initial retainer. Any unused retainer will be applied to any balance or refunded.

Cancellation Policy: Notice of cancellation or rescheduling of a hearing must be submitted in writing by each side at least 45 days prior to first arbitration scheduled date. Late notice will require the requesting party to incur 100% of the fees associated with that hearing. The administrative fees are non-refundable.

b. Complex Arbitrations (e.g., Consumer Cases, Contracts)

- **Plenary Session:** \$7,500 per plenary session day + \$2,250 per side (per stirpes) nonrefundable administrative fee.
 - Case management conferences, status conferences, motion practice, and preparation of reasoned award at \$500 per hour.

- **Maximum Hours for Award Preparation:** Typically, not exceeding 20 hours (determined at pre-arbitration conference).
- **Advance Payment:** Administrative fees and 10-hour retainer for professional fees will be invoiced at setup.
- **Payment for Scheduled Sessions:** Required 90 days prior to the start of plenary sessions.
- Hourly fees are billed as incurred, we reserve the right to invoice for additional retainer upon use of initial retainer. Any unused retainer will be applied to any balance or refunded.

Cancellation Policy: Notice of cancellation or rescheduling of a hearing must be submitted in writing by each side at least 45 days prior to first arbitration scheduled date. Late notice will require the requesting party to incur 100% of the fees associated with that hearing. The administrative fees are non-refundable.

3. Temporary Judgeships/Trials/References by Stipulation

a. Simple Matters (e.g., Consent Probate Matters)

- **Half-Day Session:** \$3,000 + \$1,000 non-refundable administrative fee
- **Full-Day Session:** \$7,500 per plenary session day + \$1,500 non-refundable administrative fee
 - Minimum of half-day sessions.
 - Motion practice and preparation of reasoned award/ruling at \$500 per hour.
 - **Maximum Hours for Award Preparation:** Typically, not exceeding 10 hours (determined at pre-hearing conference).
 - **Advance Payment:** Professional and administrative fees required and invoiced upon scheduling. Hourly fees are billed as incurred, we reserve the right to invoice for additional retainer upon use of initial retainer. Any unused retainer will be applied to any balance or refunded.

Cancellation Policy: Notice of cancellation or rescheduling of a hearing must be submitted in writing by each side at least 45 days prior to first trial hearing scheduled date. Late notice will require the requesting party to incur 100% of the fees associated with that hearing. The administrative fees are non-refundable.

b. Complex Trials or Contested Matters (e.g., Family Law, Contested Matters)

- **Plenary Session:** \$7,500 per plenary session day + \$2,250 per side (per stirpes) nonrefundable administrative fee
 - Case management conferences, status conferences, motion practice, and preparation of reasoned award at \$500 per hour.
 - **Maximum Hours for Award Preparation:** Typically, not exceeding 20 hours (determined at pre-arbitration conference).
 - **Advance Payment:** Administrative fees and 10-hour retainer for professional fees will be invoiced at setup.
 - **Payment for Scheduled Sessions:** Required 90 days prior to the start of plenary sessions
 - Hourly fees are billed as incurred, we reserve the right to invoice for additional retainer upon use of initial retainer. Any unused retainer will be applied to any balance or refunded.

Cancellation Policy: Notice of cancellation or rescheduling of a hearing must be submitted in writing by each side at least 45 days prior to first trial hearing scheduled date. Late notice will require the requesting party to incur 100% of the fees associated with that hearing. The administrative fees are non-refundable.

4. References by Court Appointment and Administrative Hearings

- **Hourly Rate:** \$500 per hour + \$1,000 non-refundable administrative fee
 - Payment for retainer or administrative fees will be discussed at setup.

Payment Terms

- **Deposits:** Required for all services upon scheduling.
- **Invoices:** Sent upon scheduling and 90 days prior to the start of plenary sessions.

Cancellation Policy: Notice of cancellation or rescheduling of a hearing must be submitted in writing by the moving party at least 10 days prior to any motions or management hearings scheduled date. Late notice will require the requesting party to incur 100% of the fees associated with that hearing. The administrative fees are non-refundable.
